

2025 Food Vendor Rule

VENDOR hereby contracts with the Community Club of Kendall for space in the Kendallfest Celebration as follows:

VENDOR agrees to use and pay for the food booth space as described. VENDOR agrees to accept space assigned and will not sub-let to anyone else.

Neither the Community Club of Kendall, the Kendallfest Committee, nor the Village of Kendall will be responsible for any injury which may arise to VENDOR, their employees, agents, guests, or customers, or for the loss, theft of or damage to any food, displays, merchandise, samples or vehicles from any cause whatsoever while in transit to or from, or while participating in the Kendallfest Celebration. By executing this contract, VENDOR agrees absolutely and irrevocably to waive and release any claim it may have against the Community Club of Kendall, the Kendallfest Celebration, the Village of Kendall, their officers, officials, agents or employees

When ACTS OF GOD or any other cause not within the control of the Community Club of Kendall, Kendallfest Celebration and the Village of Kendall, their officers, officials, agents, or employees are jointly released from any and all claims for damages which may arise as a consequence thereof.

The VENDOR also agrees to the following conditions of this contract:

- Set up shall be completed by 4:30 pm the first day of contract.
- If using electric hookup all extension cords provided by VENDOR.
- If using water VENDOR will provide all hoses and splitters.
- Only food specified in contract may be sold.
- No CARRY INS of any Alcoholic beverages will be permitted.
- Booth sharing by VENDORS is not permitted.
- The management shall be entitled to close an exhibit at any time for failure of VENDORS to perform, observe and comply with any terms set forth in this contract.
- The VENDOR agrees to use only qualified labor at all times.
- VENDOR shall not be entitled to a refund or any part of any fee should he/she, for any reason, is unable to participate after acceptance.
- If for any reason management determines that the location of the food VENDORS should be changed, management reserves this right.
- All pertinent laws, ordinances and regulations pertaining to health and public safety shall be strictly observed.
- Food VENDORS shall have appropriate license, and insurance
- VENDORS will cooperate by keeping the Vendor area clean.

- The number of food VENDORS will be Limited by their menu. Applications will be reviewed as received and accepted or rejected on a first come first serve basis.
